

What are Traditional Cultural Places (TCPs)?



Traditional cultural places (TCPs) are defined by the National Park Services (NPS) as "...a building, structure, object, site, or district that may be listed or eligible for listing in the National Register for its significance to a living community because of its association with cultural beliefs, customs, or practices that are rooted in the community's history and that are important in maintaining the community's cultural identity."

(NPS 2024:7)

TCPs are an official type or kind of historic property.



Why are TCPs important to identify, record, and officially register?

As cultural anchors to place, ancestral knowledge, and practices, wahi kūpuna are strikingly similar to traditional cultural places. So, there is some alignment between the Hawaiian concept and understanding of wahi kūpuna and the official designation of a TCP.

Official TCP recognition bundles together the intangible and tangible parts that contribute to the cultural importance and significance of a place in ways that dots on a map and bounded sites typically do not. They can, if designed and researched with intention, identify and connect the significant components of a place.

Ideally, registering places as TCPs in Hawai'i should ensure a more holistic understanding and recognition of their Hawaiian cultural significance.

During historic preservation and environmental compliance processes, official TCP designation means project impacts are measured against all the components of the TCP.



Types of Historic Properties and TCPs

STRUCTURE

"The term 'structure' is used to distinguish from buildings and functional constructions for purposes other than creating human shelter." (NPS 2024:9).

OBJECT

"The term 'object' is used to distinguish from buildings and structures those constructions that are primarily artistic in nature or are relatively small in scale and simply constructed. Although it may be movable, by nature or design, an object is associated with a specific setting or environment." (NPS 2024:9).

SITE

"A site is the location of a significant event, occupation or activity, or a building or structure, whether standing, ruined, or vanished, where the location itself possesses historic, cultural, or archeological value regardless of the value of any existing structure." (NPS 2024:9).

DISTRICT

"A district possesses a significant concentration, linkage, or continuity of sites, buildings, structures, or objects united historically or aesthetically by plan or physical development." (NPS 2024:9).

BUILDING

"A building ... is created principally to shelter any form of human activity. 'Building' may also be used to refer to a historically and functionally related

unit[.]" (NPS 2024:9).



What are "Historic Properties" and Other Heritage?

Below are definitions of "Historic Properties" from the National Park Service, the National Historic Preservation Act, and the Hawai'i Revised Statutes.

"Historic properties are any prehistoric or historic districts, sites, buildings, structures, or objects that are eligible for or already listed in the National Register of Historic Places. Also included are any artifacts, records, and remains (surface or subsurface) that are related to and located within historic properties and any properties of traditional religious and cultural importance to Tribes or NHOs." (NPS 2012)

National Park Services (NPS)

"[P]rehistoric or historic district, site, building, structure, or object included in, or eligible for inclusion on, the National Register of Historic Places, including artifacts, records, and material remains related to such a property or resource." 54 U.S.C. §300308.

National Historic Preservation Act (NHPA)

"[A]ny building structure, object, district, area, or site, including heiau or underwater site, which is fifty years old." (HRS §6E-2).

Hawai'i Revised Statutes (HRS) §6E




TCPs can be officially recognized in the following ways:

State Inventory of Historic Places (SIHP): the official, ever-expanding inventory of historic properties in Hawai'i.

Hawai'i Register of Historic Places (HRHP): "an official list of properties that have been recognized for their significance to the history, architecture, archaeology, or culture of Hawai'i communities." (SHPD 2024)

National Register of Historic Places (National Register):

"the official list of the Nation's historic places worth of preservation" (NPS 2024:99). The purpose of the NRHP is to recognize, not protect, historic properties.





Review the <u>NPS Guidance</u> on NRHP listing and TCPs.

Prepare a TCP study.

Complete an <u>SIHP</u> <u>request form</u> of your wahi as a TCP.

Prepare an <u>HRHP</u> <u>Nomination</u> **OR** Prepare a Combined <u>HRHP and NRHP</u> <u>Nomination form</u>.

Submit the nomination to the SHPD for review by the HPRB <u>deadline for</u> <u>consideration</u>.

Revise the nomination per SHPD's request, if necessary.

Resubmit the nomination to the SHPD, who submits the nomination to the HPRB.

Submit the public comment to the HPRB, if desired. Can also request others to submit public comment to the HPRB.

Attend the HPRB nomination hearing and potentially answer questions about the nomination.

Revise the nomination per the HPRB's request, if necessary.

Steps 12-15 are optional should you choose to pursue a NRHP listing.



Ensure the SHPD submits your nomination to the NRHP within the 90 day timeframe mandated by law.



Track the progress of your nomination in the NRHP's 45 day review process. If desired, submit public comment in support of your nomination and encourage others to do the same. The NPS will publicly report the nomination in the Federal Register.

Prepare a TCP Study

Deeper dive background research with an emphasis on Hawaiian primary sources and oral traditions:

- 1.Cultural practices and resources associated with the place, including oral traditions.
- 2. Hawaiian and other primary accounts of the place.
- 3. Ali'i associated with the place.
- 4. Māhele 'Āina information.
- 5. Historical trajectories and uses.
- 6.What is the place like today? (current condition + uses)


Ethnography of those who carry knowledge about a place, if applicable.

How does the information gathered in the prior parts inform the question below?

- 1. In what ways does the place maintain its integrity? how does that correlate with the official, technical definition of integrity?
- 2. In what ways does the place carry cultural significance? How does that correlate with the official, technical definition of significance?
- 3. What significance threshold criteria does the place meet?
- 4. Does the place also meet the additional significance <u>threshold criteria for Hawai'i</u>?




Register Program Description

Hawai'i State Historic Preservation Division maintains the list of nominated properties, properties listed in the Hawai'i Register of Historic Places, and Hawai'i properties listed in the National Register of Historic Places.

Hawai'i Register of Historic Places:

The Hawai'i Register of Historic Places is an official list of properties that have been recognized





Steps 7-15 consist of revising and resubmitting nomination forms.

There is a public comment period for each submitted nomination. The public comment period occurs one month prior to the HPRB hearing and upon initial NPS submittal.
